# SECTION 4 : FIRST AID MEASURES

# 4.1. Description of first aid measures

# In the event of exposure by inhalation :

# In the event of splashes or contact with skin :

If the contaminated area is widespread and/or there is damage to the skin, a doctor must be consulted or the patient transferred to hospital.

# In the event of swallowing :
